Mondrian Investment Partners Limited ("**Mondrian**"), an entity duly incorporated under the laws of the United Kingdom, in its capacity as investment manager and on behalf its affiliates who are also investment managers with clients outside of Brazil, in compliance with Article 12 of the CVM Instruction No. 358, dated January 3, 2002 ("**Instruction 358/02**"), hereby informs that the portfolios of clients under its or its affiliates' management have sold, through certain transactions on stock exchanges, directly or through American Depositary Receipts – ADRs, certain shares issued by **Suzano S.A. ("Company")**, thus holding, currently **21,328,801** (twenty one million, three hundred and twenty-eight thousand, eight hundred and one) shares, representing **1.57%** of all shares issued by the Company.

2. This is a minority investment that does not involve a change in the composition of corporate control or a change in the management structure of the Company. Currently, Mondrian and its affiliates do not intend to purchase any additional shares of
